
That said, it should be noted that the UNICEF 2024 report emphasizes that *"the current rate of FGM reduction is insufficient to achieve the United Nations Sustainable Development Goal of eliminating FGM by 2030."*

The numbers speak for themselves, and they are atrociously, intolerably impressive.

This is happening in more than 30 African countries (list below), with Somalia topping this terrifying list with **99%** of Somali Women undergoing sexual mutilation, most often in repugnant, inHumane, undignified, contemptuous sanitary conditions, conditions that reveal the existence in Islamic ideology of a millennia-old endemic misogyny

« Female genital mutilation (FGM) or excision refers to the total or partial removal of the external female genitalia. It is generally performed with a knife or razor blade, with or without anesthesia».

In fact, it is almost always without anesthesia, partly because of the morbidly excessive submission to "the said" sacrosanct tradition, and partly because of the costs and unavailability of anesthesia in small villages as well as in cities.

« The procedures can range from rubbing or total or partial removal of the clitoral hood to partial or total removal of the clitoris and labia, or even suturing the labia to close the vulva, which is called infibulation ».

«FGM has no known health benefits, and among the most common complications are bleeding during the procedure, urinary tract infections, painful periods, and chronic pain».

«Excision is generally performed on girls between the ages of 4 and 8. Women and girls subjected to genital mutilation routinely endure **excruciating physical suffering**».
